Frequently Asked Questions

HOW CAN MFDA OFFER SUCH HIGH QUALITY TRAINING AT THIS LOW PRICE?

IS THE \$75 CHARGE PER FUNERAL HOME OR PER PERSON.

HOW CAN ONE TELEPHONE LINE WORK FOR OUR FIRM?

HOW DOES THIS WORK?

- 1.) First register your firm as a participant with MFDA.
- 2.) Give us an estimated number of participants so we can reserve the space.
- 3.) We'll provide you with phone in instructions and a code number to access the session, as well as CEU details.
- 4.) We'll also provide you with instructions for downloading the hand out materials or if you do not have internet access, you need to order your handouts from MFDA.

HOW DO I RECEIVE CEU'S FOR PARTICIPATION?

Each funeral establishment will be assigned a code for participating in the teleconference. On the day of the call, please follow the instructions for logging in to the teleconference site. We'll take it from there!

ARE THERE ANY HIDDEN COSTS?

No, if you have internet access and the ability to download and print the handouts.

Please note: If you do not have access to the internet or want us to provide you with printed handouts, there is a \$10 per person charge. This includes the printing and postage cost. In order to have us provide the handouts, you must be registered not later than 1 week before each session.
