### Register Your Funeral Establishment Today!

We are offering our annual OSHA training sessions via webinar on the Zoom platform again this year. The one-hour session allows everyone on your staff to complete their annual OSHA certification at the same time for one low cost. OSHA training is required for all licensed funeral home staff and apprentices (as well as Massachusetts Registered Funeral Home Assistants) and has been approved for 1 CEU Credit by the Massachusetts State Board in Embalming and Funeral Directing as well as APFSP for Connecticut participants. This course complies with all OSHA requirements for annual training, including bloodborne pathogens.

There are six sessions remaining to choose from! The cost for the training is \$125 per funeral establishment per session for member firms regardless of the number of participants attending the session or \$250 per individual/funeral home participant for non-members. Handouts, CEU forms, and instructions on how to join the Zoom session will be sent once your funeral establishment's registration has been completed and confirmed.
